

The law is a rule of conduct that applies to everyone. Protecting both the individual and society, it lies at the meeting point between the general interest and individual freedom. It defines our rights, but also our duties. It can therefore prohibit or even punish certain dangerous or harmful acts to oneself or to the community. Preventing and anticipating the risks of breaking the law are healthy principles of community living.

French legislation

Illegal use of any substance or plant classified as a narcotic is subject to one year's imprisonment and a fine of 3,750 euros.

Persons guilty of this infraction are also subject, as an additional penalty, to an obligation to complete a training course to raise awareness of the dangers of using narcotics, in accordance with the procedures specified in article 131-35-1 of the French Penal Code.

French Public Health Code - article L3421-1

An accomplice to a crime or delict is any person who knowingly, by aid or assistance, facilitated its preparation or consumption.

An accomplice is also a person who, by gift, promise, threat, order or abuse of authority or power, has induced an illegal act or given instructions for its commission.

French Penal Code - article 121-7

The fact of **servicing drinks to people who are obviously drunk, or of admitting them to their establishments**, is subject to the fine laid down for 4th class infractions.

French Public Health Code - article R3353-2

Even in the absence of any obvious signs of drunkenness, **driving a vehicle in an alcoholic state characterized by a blood alcohol concentration equal to or greater than 0.5 grams per liter**, or by an alcohol concentration in exhaled air equal to or greater than 0.25 grams per liter, without reaching the thresholds specified in article L-234-1, is subject to a 4th class fine.

French Highway Code - article R234-1

The management of Grenoble INP-UGA is aware of the serious dangers posed by the consumption of alcohol and drugs to students' health and social behaviour. Decree 2006-1386 on the fight against smoking and alcoholism lays down the principle that **smoking is prohibited in places intended for collective use, except in areas reserved for smokers.**

Smoking is therefore prohibited in all communal areas, **including those used for non-school activities.**

It is forbidden to enter or remain on these sites while under the influence of alcohol or drugs. The school management will ask any competent authority to acknowledge a state of drunkenness and to take the necessary conservatory measures.

The introduction and consumption of alcoholic beverages on the school's site is forbidden, unless authorized in writing by the director or his delegate.

The introduction and consumption of any illicit product such as cannabis is forbidden on the site of Grenoble INP-UGA.

Student living areas are the responsibility of the student associations using them. **The introduction or consumption of alcohol is strictly forbidden.**

As a reminder, hazing and harassment are defined as offenses subject to fines and/or imprisonment.

Hazing is the offence of inducing others, against their will or not, to undergo or commit humiliating or degrading acts, or to consume alcohol excessively, during events or meetings associated with school, sports and socio-educational environments. Hazing is subject to six months' imprisonment and a fine of 7,500 euros. In cases of violence, threats or sexual abuse, the penalties can extend to 10 years' imprisonment (French Penal Code - article 225-16-1).

Harassment is defined as repeated verbal, physical or psychological violence. Under the French penal code, harassment is punishable by two years' imprisonment and a fine of 30,000 euros (penal code - article 222-33).

Applicable sanctions:

Any person failing to comply with the terms of this charter may have his/her case referred to the Disciplinary Commission of the Grenoble INP-UGA Board of Directors, which may impose a sanction up to and including expulsion from the institution, without prejudice to any criminal proceedings foreseen by law.

The signature of this document constitutes an undertaking to respect the above rules and regulations. In addition, the student undertakes to adopt a civic-minded attitude and to respect ethical values in compliance with the image of Grenoble INP-UGA.
